

TERMS AND CONDITIONS

The placement of orders by Distributor to M.O.C. Woodworks will constitute an agreement by Distributor to the following:

PRICING: Retail distributor agrees to comply with M.O.C. Woodworks guidelines for MAP. (Minimum Advertised Price). Violation of these guidelines may result in disqualification of status as approved distributor.

INITIAL ORDERS: \$600.00 minimum Dealer Cost.

MINIMUM RE-ORDERS \$300.00 (Dealer Cost). Orders for less than minimum are subject to \$10.00 service charge.

TERMS

All invoices are due 30 days following the date of invoice on approval of credit. A Late Payment Charge of 1.5% per month (18% per year) will be applied to delinquent balances. No orders will be shipped to an account which is 60 days overdue, except on a cash-in-advance basis that includes a portion of the delinquent amount. Credit card payments will be charged on invoice date. Orders are subject to acceptance by M.O.C. Woodworks San Rafael, California.

MAP PRICING

M.O.C. Woodworks has established a Unilateral MAP (minimum advertised price) policy on all M.O.C. Woodworks products.

M.S.R.P. Manufacturer's Suggested Retail Price. All prices are subject to change without notice.

F.O.B. POINT & SHIPPING CHARGES: All shipments are FOB San Rafael, CA. Distributor is responsible for both shipping charges and damage to goods in transit. M.O.C. Woodworks will prepay UPS shipments and the cost will be added to each invoice unless otherwise specified. Distributor must specify a freight carrier (if other than UPS) at time the order is placed. All other freight or handling charges, taxes and duties beyond the F.O.B. point are the responsibility of the Distributor.

INTERNET SALES: M.O.C. Woodworks products may be marketed and sold on retail distributor's website providing M.A.P. guidelines are followed. Products may be offered for sale on the Amazon Marketplace ONLY if Merchant Fulfilled. Retail distributors are not authorized to sell on Amazon via Fulfilled by Amazon (FBA).

SALE OF M.O.C. Woodworks PRODUCTS ON INTERNET AUCTION FORMAT IS PROHIBITED

SHORTAGES/DAMAGES: Please inspect all shipments immediately upon arrival. Claims of shortages/damages must be made to the freight carrier. Claims to M.O.C. Woodworks must be made within 10 days of receipt.

CONSUMER SALES ONLY: Retail distributor will make best effort to sell products to individual consumers other end-user entities only, and not engage in sales to other distributors, either e-commerce or brick and mortar.

MERCHANDISE RETURNS: Requests for merchandise returns, regardless of reason, require written approval from M.O.C. Woodworks. Authorized returns are subject to a 15% re-stocking charge. Authorized returns must be shipped Prepaid to M.O.C. Woodworks with a valid RMA# clearly written on the outside of each box. Unauthorized returns will be refused. Customized merchandise can't be returned unless it is defective.

NATURAL WOOD: Since the M.O.C. Woodworks products are made out of wood with a clear finish there will be variations in color/grain, this variation are not considered a defect.

WARRANTY: M.O.C. Woodworks warrants that the M.O.C. Board will be free of defects in materials or workmanship under normal home use for one year from the date of purchase. We will, at our option, repair or replace a M.O.C. Board that is determined to be defective without charge. This warranty does not apply to commercial use or product damage through abuse, or negligence.
